(b)	<p>Description of in-kind donations:</p> <p>*Coats / total value: \$1,072,632 (gently-used coats: \$1,057,632 / new coats: \$15,000) New York Cares runs an annual Coat Drive through which we collect coats (the majority of which are gently-used, although we sometimes receive donations of new coats) and distribute them to New Yorkers in need. During the 2012 Coat Drive (November 15-December 31), 36,675 of the total coats we collected were given to New Yorkers hardest hit by Sandy, via 115 agencies in the New York City zip codes declared disaster areas by the federal government in the wake of the storm. These coats included:</p> <ul style="list-style-type: none"> -13,685 men's gently-used coats (valued at a total of \$437,920) -13,401 women's gently-used coats (valued at a total of \$536,040) -6,840 children's gently-used coats (valued at a total of \$68,400) -1,909 infants' gently-used coats (valued at a total of \$15,272) <p>- 840 new children's coats donated by BNY Mellon (valued by the donor at \$15,000), which we distributed at our Coat Drive kick-off distribution event at the Far Rockaway Library.</p>

	<p>*Warehouse space / value: pending response by donor Rudin Management Company, Inc. and The ABNY Foundation donated 40,000 square feet of warehouse space from November 12, 2012 through January 4, 2013. After Sandy hit, the impacted communities were overwhelmed by a deluge of in-kind donations (canned and perishable goods, clothing of all sorts, supplies, etc.), which the communities were in no position to store or effectively distribute. In response, the Mayor's Office enlisted New York Cares' assistance and secured for us this donated warehouse space where staff and teams of New York Cares volunteers sorted through the donated items to prepare them for distribution to storm victims by organizations like Housing Works, City Harvest and Goodwill. While we provided significant assistance with this effort, New York Cares did not, itself, solicit in-kind donations beyond coats for our Coat Drive.</p> <p>*Video Production Services / value: \$12,000 IKA Collective donated \$12,000 worth of pro-bono services to produce a video on New York Cares' hurricane response efforts.</p>
(c)	<p>Explanation of how in-kind donations were valued:</p> <p>*Coats</p> <ul style="list-style-type: none"> • Gently-used coats: Valued at \$8 for infant, \$10 for children, \$40 for women and \$32 for men, for a total value of \$1,057,632. To establish the value of donated gently-used coats (which we have included in our audited financials since 2008), New York Cares surveyed organizations with significant experience in collecting and selling donated used items (e.g., Salvation Army, Goodwill Industries and Housing Works). Simultaneously, our Coat Drive staff members (who were not privy to our benchmarking of other organizations) researched the cost of various categories of coats to establish their estimate of the cost. That value estimate was within the range we had collected during our benchmarking exercise. Our Audit Committee reviewed the information and, in collaboration with our auditors, New York Cares established the values of the various categories of coats. We have used the same values since August of 2008. • New children's coats: Valued at \$15,000 by the donor, BNY Mellon. <p>*Warehouse space: Value pending. We are working with the donor, Rudin Management Company, Inc. and The ABNY Foundation, to get the fair market value of their donation.</p> <p>*Video Production Services: Valued at \$12,000 by the donor, IKA Collective.</p>

4.	Please describe the types of assistance that your organization has provided to those affected by Hurricane Sandy. What populations or geographical areas have been (or will be) served by your organization in response to Hurricane Sandy?	
	<p>In the wake of Hurricane Sandy, many residents in areas including the Rockaways, Staten Island, and Southern Brooklyn, lost not only their power and water but also their access to the services of local nonprofits and churches, which were also incapacitated. The storm destroyed the already limited social services infrastructure in these neighborhoods. As so many New Yorkers struggle with the most basic needs, New York Cares is there to help.</p> <p>Since the storm hit, our recovery programming in the impacted communities in the Rockaways, Coney Island, Red Hook and on Staten Island has included canvassing to assess damage; the distribution of food, water and other critical supplies; and the collection and distribution of 36,675 coats to individuals via agencies in the New York City zip codes declared disaster areas by the federal government in the wake of the storm. We also answered 15,940 Winter Wishes (holiday gift request) letters from 10 schools and agencies in the impacted zip codes. Our post Sandy work has also included the muck out of 350 homes (to date) and the mold treatment of 15 homes and other</p>

	<p>buildings (to date). In addition, we are expanding our ongoing health, education and community revitalization programming in the hardest hit communities. For example, we started our Rockaway Readers Club, an ongoing Saturday children’s literacy program at the Far Rockaway Library. At Snug Harbor, a Staten Island nonprofit, a New York Cares technology volunteer taught the Snug Harbor staff how to use Google Apps and Google Forms to streamline the volunteer sign-up process for post-Sandy and ongoing projects.</p> <p>To implement all of the post Sandy projects, we have hired additional New York Cares staff members to (1) lead teams on daily mucking out projects; (2) respond to the increased influx of volunteers and inquiries from the general public; (3) train and support an increased number of volunteer leaders for disaster response programming, and (4) oversee health, education and community revitalization program implementation in the affected areas in Queens, Brooklyn, and Staten Island.</p>

	<p>We are finalizing discussions with the American Red Cross, which will provide funding for volunteer muck out and mold remediation. We are also negotiating a contract with Neighborhood Revitalization NYC, LLC for volunteer muck out and mold remediation. Neither agreement nor amount of funding is finalized as of March 18, 2013.</p> <p>We are not actively soliciting other donors for Hurricane Sandy relief/response efforts, and although additional funding may come in, we do not anticipate that it will be significant.</p>
10.	Is your organization still conducting relief efforts? If so, please describe how individuals, businesses or organizations seeking assistance can contact your organization.
	We continue to conduct the relief efforts described above. Volunteers go through our site at newyorkcares.org (and group volunteers go through our staff). Homeowners requesting help with muck out or mold removal call 347-306-9160, which is specially staffed to address their needs.
