4.	Please describe the types of assistance that your has organization provided to those affected by Hurricane Sandy. What populations or geographical areas have been (or will be) served by your organization in response to Hurricane Sandy? Islamic Relief USA provided direct assistance to the survivors of Hurricane Sandy from the beginning of the storm by working in partnership with the American Red Cross to set up shelters in the state of New Jersey. Our Disaster Assistance Response Team ("DART") worked in 2 different shelters that each housed approximately 300 people for 1 week. Islamic Relief USA then moved into clean up phase as we worked in New York City and a number of communities in New Jersey "mucking out" homes that had been ravaged by the storm waters. We assembled about 100 volunteers who helped to clean out homes of flooring, carpet, drywall, etc. to ensure mold infestation did not begin to grow. This effort was in place for approximately 1 month, November 14 through December 15, 2012.

We then moved into the long term recovery phase of our effort by partnering with a local organization based in New Jersey named SMILE. We have worked with them previously. We used funds raised to support victims of Hurricane Sandy to purchase and distribute food to families that had been affected by Sandy. The food boxes purchased contained enough food to feed a family for approximately 4 days. 500 boxes were assembled and distributed in partnership with SMILE from December 13 through 16, 2012

Islamic Relief continues to support the survivors within the Northeast region through 3 partnerships with organizations who work within New York city in the following areas:

Coalition of Hope (COH) - mold remediation activity within New York City, identifying continuing mold abatement needs and addressing possible health concerns. IRUSA has provided a grant totaling \$159,000 to assist COH in their mold remediation efforts for approximately 500 homes.

New York Disaster Interfaith Services (NYDIS) – NYDIS is addressing the unmet food needs of individuals whose homes were located within an affected portion of the city and who are eligible for food vouchers that could be used at local food stores. IRUSA has provided a grant totaling \$80,000 to provide food vouchers to beneficiaries identified by NYDIS.

Health and Welfare Council of Long Island (HWCLI) – HWCLI assembled a roundtable to identify and address the unmet needs of survivors of Hurricane Sandy. IRUSA provided a grant totaling \$60,000 to address the unmet needs of approximately 200 individuals who were identified by the roundtable.

Islamic Relief USA has provided grants to organizations to assist Super Storm Sandy Survivors. The following 4 organizations have received grant funds:

- 1. Smile-\$12,765, food distribution
- 2. NYDIS-\$80,000, food vouchers
- 3. HWCLI- \$60,000, unmet needs of local community
- 4. COH- \$159,000, mold remediation activities

Islamic Relief USA has a Grant policy that ensures that grantees have the ability to support communities in line with our priority sectors. Projects are screened internally by committee, and then sent to our board of trustees for final approval. Monitoring of the

	grant is then accomplished through initial, interim and final reports that assure the needed community receives the support outlined in the grant agreement. Islamic Relief USA works with FEMA, Unmet Needs Roundtable committees and local VOAD's to ensure compliance with the outlined agreements.

	Islamic Relief USA will spend all funds designated for Hurricane Sandy relief at the close of Hurricane Sandy relief projects. Currently, Islamic Relief USA has spent more money from general relief funds than has been donated to date.
